## **Refund Policy**

I will receive one preliminary drawing, two revisions, a final draft and six copies of the drawings once completed. I understand that the level of detail of these drawings is commensurate with the aforementioned "Conceptual plan set" and does not include the level of detail that is included in the "Progress plan set" whose fee is non-refundable. I further understand that my deposit will be refunded after the completion of the project if purchased entirely through Hammond Lumber Company. Furthermore, 20% of my refund will be forfeited for each of the following five (5) items if they are not purchased through Hammond Lumber Company: (1) Windows, (2), Interior and Exterior Doors, (3) Kitchen, (4) Flooring, (5) Roofing & Siding. "Refund amount will be based on the amount of materials purchased at Hammond Lumber Company."
